ORDER

Perused the resolution No. (C) of the minutes of the Committee constituted for providing prior permission as per which the applicant institution has fulfilled all required information, in pursuance of the Govt. letter No. ASE. 135/2016/Pt-II/3 dated 31/03/2017 & proposal received from the District Elementary Education Officer, Lakhimpur vide letter DEEO/L/8585 dated 25/09/2020 also as per power conferred in the Sub-Section (2) of the Section (4) of "The Assam Non-Govt. Educational Institution (Regulation & Management) Act 2006", Rule 3 of the "Rules 2007" in the "Assam Non-Govt. Educational Institution (Regulation & Management) Rules 2007", and "The Assam Non-Govt. Educational Institution (Regulation & Management) (Amendment) Act, 2018", Prior Permission is hereby accorded to **GYAN EDUCATIONAL INSTITUTION, Kathani Road, Harmoti, P.O.: Merbil, Dist: Lakhimpur (Assam), PIN: 784160** with immediate effect subject to the following terms & conditions and withdrawal of Prior Permission at any time:-

1. The order for Prior Permission for Class I to VIII shall be valid for 2 years.
2. The school authority shall constitute the School Managing Committee as per the Section 12 of the Act 2006.
3. The land documents of the Educational Institution must be in the name of the said Educational Institution. The Institution shall own land and possess a minimum area of 2 (two) Bighas of land in one plot before Provisional Registration of the Institution.
4. The school authority shall have to fulfil all requirements as required under the Section 10 of the Act 2006 & Section 7, 8, 9, 10, 11, 12, 13 & 14 of the Rules 2007.
5. The school authority shall prepare a scheme of Management as required under Section 14 of the Act & Rule 16 of the Rules.
6. The school authority shall apply for Provisional Registration of the school in Form II (Rule 4) within a period of 2 years alongwith required copies of all documents as per section 4 (5) of the Act 2006.
7. In case of failure to complete the task within the specified period of 2 years this order shall stand cancelled.
8. The other terms & condition laid down in "The Assam Non-Govt. Educational Institution (Regulation & Management) Act 2006 & Rules 2007" and "The Assam Non-Govt. Educational Institution (Regulation & Management) (Amendment) Act, 2018" is to be followed.
9. The school should fulfil the conditions of RTE Act 2009 before submission of proposal for provisional Registration of the school within the period and fulfilment of condition section 10 of the Act.
10. If the medium of the institution is English, then Assamese must be introduced as a subject in the Elementary Level. The institution shall follow the three languages formula in teaching language as adopted by the Central & Secretary Govt. as per the Section 9 (Chapter V) of the Rules 2007.
11. Curriculum CBSE.
12. No financial grant / assistance will be claimed by the institution from the Govt. at any condition.
13. Under qualified teachers must be removed as per RTE, Act, 2009.
14. Performance Report of the school for the last three years should be submitted.
15. The teacher must be trained up (D.El.Ed.) within the 31st March, 2019 as per the Govt. of India letter D.O. No. 17-2/2017-EE.17 dtd. 03/08/2017.
16. The institution has to admit 25% of students from the reserved quota as per the section (12) C of the RTE Act 2009.
17. The school authority shall obey the instruction of the Section 4 of Amendment of Section 15 of the Principal Act, 2006 in the "Assam Non-Government Educational Institution (Regulation & Management) (Amendment) Act, 2018".
18. The school authority must submit the "Disaster Management Plan" of the Educational Institution within 15days from the date of receipt of the Prior Permission order.
